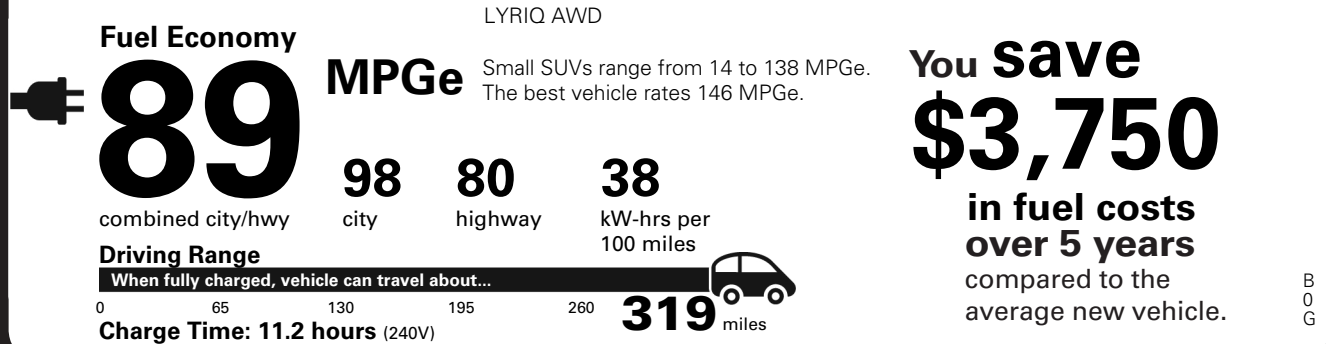

Electric Vehicle

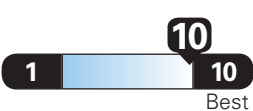
